### **CHAPTER I**

#### INTRODUCTION

Every Indonesian Citizen has a right to ask for the state land property right. Whereas foreigners who live in Indonesia also have the right to apply for it. But those rights are limited by the regulation of legislation for managing a connection between the land and the owner. The owner who has the right to ask for the land property right in a certain land is the person has a connection of law or importance in a certain land.

Asking is the right of every person, but issueing or rejection of land property right is the state authority which will be taken based on the regulation of legislation. Land Property Right Issue is a precidential decision giving a state land property right including the Extention of the right time span and Renewing Right. Land Property Right Issue is caried out by the competent official followed by its registration at National Land Agency in Regency/ Municipality. And delegation of the authority in issueing and rejection of the land property right decree is based on the decree of Agrarian State Minister/ the Head of National Land Agency No. 3/ 1999.

Based on those reasons, the writer finds it interested to entitle The Procedures of Issueing Land Propety Right at National Land Agency in Semarang Municipality.
