ABSTRAK

TINJAUAN KELENGKAPAN DATA KUANTITATIF DAN KUALITATIF DOKUMEN REKAM MEDIS PASIEN BPJS KASUS SECTIO CAESARIA PERIODE TRIWULAN IV TAHUN 2014 DI RSUD KOTA SEMARANG
Kelengkapan DRM sangat penting sebagai penilaian mutu pelayanan juga sebagai sumber data klaim dalam INA-CBGs. Untuk menilai kelengkapan dokumen rekam medis digunakan cara review kuantitatif, kualitatif, ketepatan kode dan kesesuaian kode dengan grouper INA CBGs. Berdasarkan survey awal pada 10 dokumen didapatkan hasil autentikasi sebanyak 100 % lengkap, pencatatan 40% tidak lengkap, pelaporan 30 % tidak lengkap, kualitatif 20% ketidaksesuaian pada pencatatan diagnosa.

Jenis penelitian yang digunakan adalah deskriptif dengan metode observasi. Populasi sebanyak 260 DRM, dengan rumus Slovin didapatkan 71 DRM.

Berdasarkan hasil penelitian terhadap 71 sampel didapatkan hasil dari review kuantitatif pada identifikasi 65 dokumen lengkap (92%), pelaporan 39 dokumen lengkap (55%), pencatatan 57 dokumen baik (80%), autentikasi 62 dokumen lengkap (87%), kelengkapan dan review kualitatif 51 dokumen lengkap (72%), kesesuaian kode ICD dengan INA CBGs 47 dokumen sesuai (66%).

Disarankan untuk melakukan sosialisasi lebih lanjut kepada petugas medis dan non medis agar pengisian dokumen rekam medis rawat inap menjadi lebih lengkap.

ABSTRACT

QUANTITATIVE AND QUALITATIVE REVIEW ON MEDICAL RECORD DOCUMENT COMPLETENESS OF BPJS PATIENT WITH SECTIO CAESARIA CASES IN THE FOURTH QUARTER IN 2014 IN SEMARANG REGIONAL HOSPITAL

DRM Completeness is very important as an assessment of the quality of services as well as data source for claims in INA-CBG's. To assess the completeness of medical record documents, the assessment applied review of quantitative, qualitative, accuracy and suitability code with code grouper INA-CBG's. Based on the initial survey, it obtained 10 document with the result of authentication as much as 100% complete, 40% incomplete record-keeping, reporting 30% incomplete, qualitative 20% discrepancy in recording diagnoses. The aim of this study was to determine the completeness of quantitative and qualitative data on inpatient medical records document of BPJS patient with Section Caesaria cases.

This type of research is descriptive with observation method. The population are 260 DRM of hospitalized BPJS patients with Sectio Caesaria cases. The samples are calculated by using the Slovin formula, and it obtained that the samples are 71 DRM of hospitalized BPJS patients with Sectio Caesaria cases.

Based on the results study of 71 samples obtained from a review of quantitative results in the identification of 65 complete documents (92%), reporting 39 complete documents (55%), recording 57 good documents (80%), authentication 62 complete documents (87%), completeness and qualitative review on the completeness and consistency of diagnosis is 59 complete documents (83%), the consistency of recording of diagnoses 59 complete documents (83%), recording things that are done when treatment 71 full document (100%), the existence of informed consent 71 complete document (100%), method or practice of recording 56 document good (79%), things that could potentially cause damages 71 full document (100%), the accuracy of the code diagnoses with ICD 71 document is accurate (100%), the suitability of ICD INACBG's 47 documents in accordance (66%).

It is suggested to further disseminate the medical and non medical personnel so that the inpatient medical records document filling become more complete.
