**ABSTRAK**

Penulisan nomor RM pada Resume Medis Pasien Pulang harus tepat dan sesuai dengan RM 1. Oleh karena itu petugas perawat harus mengerti dan memahami tentang konsistensi penulisan nomor RM. Pada survai awal di Rumah Sakit St. Elisabeth Semarang ditemukan 50% terjadi inkonsistensi penulisan nomor RM pada Formulir RM 1 dan Formulir Resume Medis. Menurut hasil wawancara petugas unit RM dan petugas perawat di ruang rawat inap, hal ini disebabkan penulisan dan pengisian nomor RM masih secara manual. Selain itu tidak digunakan komputer dalam mencetak nomor RM pasien.

Jenis penelitian adalah penelitian deskriptif dengan metode observasi dan wawancara. Populasi adalah petugas perawat di Rumah Sakit St. Elisabeth Semarang sebanyak 5 orang diambil dengan teknik total sampling.

Hasil yang diperoleh disimpulkan bahwa petugas perawat belum memahami prosedur penomoran RM, petugas perawat belum memahami prosedur penomoran manual di URI. Petugas perawat tidak mengetahui dan memahami SOP penomoran RM. Petugas perawat sudah memahami tentang sarana penomoran RM di URI. Dapat disimpulkan bahwa petugas perawat dalam penulisan nomor RM di Formulir RM 1 dengan Resume Medis Pasien Pulang di Rumah Sakit St. Elisabeth Semarang kurang teliti dan kurang memahami. Oleh karena itu disarankan petugas perawat harus lebih teliti dalam pengisian dan penulisan nomor RM di URI dan petugas perawat juga harus mengerti dan memahami tentang SOP penomoran RM di URI.

**ABSTRACT**

Writing of medical record number on Medical Resume should be appropriate to the RM 1. Therefore health care providers should know and understand about the consistency of writing of medical record number. In the initial survey in St. Elisabeth Hospital Semarang found that 50% occurred inconsistency writing of medical record number on medical resume and RM 1. According the results of interviews to medical record officer and nurses in inpatient unit, this was due to writing and filling medical record numbers still manually. Moreover it did not use a computer to print medical record numbers of patients.

This type of research was descriptive research with observation and interview methods. The population was nurses at St. Elisabeth Semarang Hospital as many as five people that taken with total sampling technique.

The results concluded that nurses did not understand the procedures of medical record numbering, nurses did not understand the procedures manual of medical record numbering in inpatient unit. Nurses did not know and understand the procedures of medical record numbering. Nurses already understand about the instrument of medical record numbering in inpatient unit. It can be concluded that in writing of medical record number in RM 1 and Medical Resume at St. Elisabeth Hospital Semarang, nurse have less conscientious and less understanding.

It is therefore recommended nurses should be more careful in charging and writing medical record number at inpatient unit and also have to know and understand about the procedures of numbering in inpatient unit.
