ABSTRAK

PJRM adalah perekam medis yang ditempatkan di bangsal untuk mengerjakan kegiatan Rekam Medis ketika pasien masih dirawat. Di RSUD K.R.M.T. Wongsonegoro Semarang banyak dokumen rekam medis yang tidak lengkap, dokumen rekam medis yang belum diassembling dan dikoding menumpuk. Penelitian ini bertujuan untuk meninjau pelaksanaan PJRM di RSUD K.R.M.T. Wongsonegoro Semarang.

Penelitian ini adalah penelitian deskriptif. Metode pengumpulan data dengan observasi terhadap pelaksanaan kepatuhan SPO, Wawancara, dan kuisioner.

Berdasarkan hasil penelitian, tersedia 11 SPO yang mendukung kegiatan PJRM di RSUD K.R.M.T. Wongsonegoro Semarang. 100% Petugas PJRM belum sepenuhnya menjalankan protap. Pengetahuan petugas PJRM tentang fungsi rekam medis kurang. Masih ada kendala dalam pelaksanaan kegiatan PJRM. Berdasarkan laporan kendali mutu, masih banyak angka ketidaklengkapan dokumen rekam medis. Berdasarkan hasil pengamatan, perlu pengadaan komputer untuk setiap petugas PJRM. Menambah petugas PJRM. Mengimbau petugas PJRM untuk lebih teliti dalam hal apapun khususnya berkaitan dengan pekerjaannya. Menekan angka kejadian ketidaklengkapan dengan mengingatkan DPJP (dokter penanggung jawab pasien) atau tenaga medis untuk melengkapi DRM.

ABSTRACT

PJRM was a medical record officers placed on the ward to do Medical Record activities when patient being treated. In Regional Public Hospital K.R.M.T. Wongsonegoro Semarang many incomplete medical record documents, medical records that had not assembled and coded were accumulate. This study aimed to review the implementation of PJRM in Regional Public Hospital K.R.M.T. Wongsonegoro Semarang.

This study was a descriptive study. Collection data method used observation on SOPs Implementation compliance, interview, and questionnaire.

Based on results, there were 11 SOPs supporting PJRM activities in Regional Public Hospital K.R.M.T. Wongsonegoro Semarang. 100% PJRM officers had not fully implemented protap. The knowledge of PJRM officers on medical record function is less. There are still obstacles in the implementation of PJRM activities. Based on quality control report, there were many incomplete medical records. Based on observations, it was necessary to provide computers for each PJRM officers. The added PJRM officers. Encourage PJRM officers to be more careful in any case especially related to their works. Prevent incompleteness by reminding DPJP (doctor in charge of patient) or medical personnel to complete medical records.
