

Analisa Persyaratan Pelayanan Puskesmas PONED dalam Pelayanan Kesehatan Ibu di Puskesmas Bangetayu Kota Semarang

ABSTRAK

AKI (Angka Kematian Ibu) di Indonesia menunjukkan peningkatan yang signifikan yaitu 359 per 100.000 kelahiran hidup. Puskesmas PONED (Post Obstetrics Neonatal Emergency Dasar) memiliki rawat inap, sarana yang memadai dan sesuai syarat pelayanan kesehatan untuk menurunkan AKI serta mendekatkan pelayanan kesehatan kepada masyarakat. Tujuan penelitian ini adalah mendeskripsikan syarat pelayanan Puskesmas PONED dalam pelayanan kesehatan Ibu.

Metode penelitian menggunakan deskriptif kuantitatif dengan pendekatan cross sectional. Instrumen penelitian menggunakan kuesioner yang menggunakan uji validitas, uji reliabilitas dan uji normalitas data. Kuesioner berisi lima syarat pelayanan kesehatan: (1) Pelayanan kesehatan yang tersedia dan berkesinambungan, (2) Pelayanan kesehatan yang wajar, (3) Pelayanan kesehatan yang mudah dicapai, (4) Pelayanan kesehatan yang mudah dijangkau dan (5) Pelayanan kesehatan yang bermutu.

Sampel penelitian berjumlah 52 responden adalah total dari semua populasi. Hasil menunjukkan bahwa syarat pertama Pelayanan kesehatan yang tersedia dan berkesinambungan berkategori cukup (62%) dan item pernyataan yang kurang tenaga medis yang siap saat keadaan darurat, Pelayanan kesehatan yang wajar berkategori cukup (56%) item yang kurang yaitu sikap petugas mau berkomunikasi dengan pasien, Syarat ketiga Pelayanan kesehatan yang mudah dicapai berkategori cukup (68%), item kurang Jarak antara rumah dengan Puskesmas PONED >2Km, Pelayanan kesehatan yang mudah dijangkau berkategori cukup (66%), item kurang Tarif persalinan di Puskesmas PONED sesuai standar kelima Pelayanan kesehatan yang bermutu dengan kategori cukup (64%) item kurang Ketersediaan tempat tidur yang memadai.

Puskesmas Bangetayu dapat meningkatkan ketersediaan sarana dan prasarana yang memadai, kemudahan akses untuk mencapai lokasi, penyediaan jaminan kesehatan bagi masyarakat kurang mampu dan mutu pelayanan guna memberikan layanan terbaik

ABSTRACT

MMR (MMR) in Indonesia showed a significant increase is 359 per 100,000 live births. PHC PONED (Post Obstetrics Neonatal Emergency Basis) have hospitalization, means adequate and appropriate health care requirements for reducing the MMR and the health service closer to the community. The purpose of this study is to describe the condition of health center services in health care PONED mother.

study was quantitative descriptive method with approach. cross sectional. The research instrument used a questionnaire that use validity, reliability test and test data normality. The questionnaire contains five terms of health care: (1) The health service provided and continuous, (2) Health services were reasonable, (3) health services within easy reach, (4) health services accessible and (5) health care quality ,

These samples included 52 respondents is the total of all the population, the results showed that the first requirement for health services provided and sustained categorized enough (62%) and the statement items are lacking medical personnel who sit during an emergency, health services were reasonable categorized enough (56%) items that are less the attitude of the officers want to communicate with patients, the third condition health services within easy reach categorized enough (68%), the item is less distance between the houses with PHC PONED > 2km, health services within easy reach categorized enough (66%), item less Rates deliveries in health centers in accordance PONED fifth standard quality medical services with sufficient category (64%) less item availability of adequate bed.

Bangetayu PHC can improve the availability of adequate infrastructure, ease of access to reach the site, provision of health insurance for the poor and the quality of services in order to provide the best service.
