**ABSTRAK**

Berdasarkan survey awal pada 10 DRM kasus external cause, 100% koding penyakit ?? namun koding aktivitas dan lokasi tidak akurat. Penelitian ini bertujuan untuk meninjau kelengkapan dan spesifitas diagnosa medis kasus external cause yang mendukung penetapan kode external cause di RSUD K.R.M.T Wongsonegoro Semarang. Jenis penelitian yang digunakan adalah penelitian deskriptif. Metode pengumpulan data dengan observasi berdasarkan pendekatan cross sectional. Subjek penelitian yaitu seluruh petugas koder rawat inap (5 petugas) dan 1 kepala rekam medis di RSUD K.R.M.T Wongsonegoro Semarang. Objek penelitian adalah DRM pasien kasus cidera atau external cause tahun 2017 periode Januari – Maret 2017. Hasil penelitian menunjukkan bahwa terdapat 3 petugas koding yang tidak mengetahui koding external cause, informasi yang tidak mendukung untuk koding external cause sebanyak 84,61 %, tidak ada SOP tentang koding external cause. 90,38 % koding tidak akurat karena informasi yang tidak lengkap. Saran perlu adanya pelatihan mengenai koding external cause.

**ABSTRACT**

Based on a preliminary survey on 10 medical records external cause cases, 100% coding disease ?? but the activity and location coding was not accurate. This study aimed to review the completion and specificity of medical diagnosis of external cause cases that support determination of external cause code in RSUD K.R.M.T Wongsonegoro Semarang. This study used descriptive study. Data collection method by observation based on cross sectional approach. The study subjects were all inpatient koder officers (5 officers) and 1 head of medical record at RSUD K.R.M.T Wongsonegoro Semarang. The study object was medical records of injury or external cause cases in 2017 period January - March 2017. The results showed that there were 3 coding officers who did not know about external cause coding, the information that did not support external cause coding as much as 84.61%, there were no SOPs about external cause coding. 90.38% coding was not accurate due to incomplete information. Suggestions need training on external cause coding.
